

PAT 2021-22: Redressal of claims against Result

In response to the University Notice issued on 03.05.2023, inviting online objections against the PAT 2021-22 Result for Admission in Coursework, a total of 75 (Seventy-five) objections were filed between 04.05.2023 and 05.05.2023. All those objections were examined and the findings thereof are as follow:

Yet remains Unselected, as the last UR candidate selected has a Total Score of 89 with a PG mark of 78.15% while this candidate has a PG mark of 77.45%. The claim is therefore not valid.
2	Education	22060396	SAIDA KHATOON	To correct PG's marks and to consider her case accordingly for selection.	The candidate has mentioned her total marks in M Ed 972.69 with full marks of 1600, thus PG marks. She has filled her percentage of marks as 60.79. Now, she claims to have M Ed for AKU securing 84% marks. The claim cannot be entertained at this stage. Second, even though her claim is considered she has 71.95% in M Ed and so she will get a Total Score of 80 (60+5+15), and the last candidate selected in EBC has a score of 83. The claim is therefore not valid.
